CIVICS (HISTORY AND GOVERNMENT) QUESTIONS FOR THE U.N.N.M. NATURALIZATION TEST

The 99 civics (history and government) questions and answers for the naturalization test are listed below. The civics test is an oral test and the Nuwaubian Nation Department of Immigration Officer, referred to hereafter as (NNDI) will ask the applicant up to 9 of the 99 civics questions. An applicant must answer 5 out of 9 questions correctly to pass the civics portion of the UNNM naturalization test.

On the naturalization test, some answers may change because of elections or appointments. As you study for the test, make sure that you know the most current answers to these questions. Answer these questions with the name of the U.N.N.M. official who is serving at the time of your eligibility interview with NNDI. The NNDI Officer will not accept an incorrect answer.

Although NNDI is aware that there may be additional correct answers to the 99 civics questions, applicants are encouraged to respond to the civics questions using the answers provided below.
